#### **Title Report Solutions**

**Title reports** are the result of extensive searches in various official record indices, intended to provide an overview of the ownership chain, encumbrances on the property and any other relevant documents pertaining to the history of the title as recorded in the official records. Title reports are typically ordered by real estate investors, attorneys, bank-owned resale divisions and title agents.

Pre-foreclosure reports support the pre-foreclosure transaction for foreclosing parties, including trustees, law firms and loss mitigation divisions. These order types span scope of search requirements ranging from a

current owner to a full title, based on statutory requirements and client preferences. Beyond a traditional title search, pre-foreclosure reports include possible proof of death research results from multiple databases in addition to Specially Designated Nationals and Foreign Sanction Evaders (Patriot Search) and Public Access to Court Electronic Records (PACER). Updates for 'default' products will be granted a 12-month period from the effective date of the previously completed DataTrace produced product, as long as ownership has not changed.

**Preliminary reports** provide the market with options for refinance and resale transactions. The report template divides the title information into schedules. Vested owner and purchaser names are searched in the Specially Designated Nationals and Foreign Sanction Evaders (Patriot Search) database as well as the Public Access to Court Electronic Records (PACER).
