**Note:** Services are county specific and may not be available in every county. The availability of and parameters used for this service may change based upon the county involved. Additionally, DTS2 is a highly customizable application and your company may not have contracted for all available services or geographies.

Finally, your company may have setup specific settings that will affect how the search and reports function and display. Please check the Profile Menu > User Profile option for information on your company settings.

## **Corporate, LP, and LLC Search Service**

This service is found under the Business Services section in the left hand Services Panel. It is used to identify and provide basic business information, such as mailing addresses, incorporation state, and status (such as active or suspended).

**Note:** The service is specific to California counties, Maricopa, Arizona and Humboldt, Nevada. The service returns data that is unique to California.

## **General Information:**

After selecting the service, enter the name of the business and click Submit at the bottom right.

The field includes automatic wild carding so the full name is not required. By default, all legal types (Corporations, Limited Liability Companies and Limited Partnerships) are included but you have the option of selecting only the ones you want.

Leaving all three selected will allow DTS2 to return all businesses in any of the three categories that match the name of the business you entered. DTS2 will provide a list of names for Corporations in one search with the LLC's and LP's in a separate search entry. Common names can yield an index of results for which a selection is needed along with the "Detail" button.
